**DIRECTIONS from:**

**Atlanta, GA:** I-85 North to I-985 North which becomes Hwy 365 and Hwy 123. Follow signs to Toccoa, turn left at Jeanette Jamieson intersection (Traffic light with Shell gas Currahee St./GA-184/US-123) proceed 3.2 miles. Turn Left on Broad St (GA-184) for 2/10 mile. Turn right on Tugalo St. for 7/10 miles. Turn Left at light on Prather Bridge Road (GA-184 ). Proceed 5 miles and turn left onto Yonah Dam Road. Proceed 4.5 miles to Yonah Dam Park.

**Greenville, SC:** From I-85 South to exit 173 (Hwy 17 Toccoa/Lavonia) Turn left at end of exit ramp toward Toccoa. Proceed 15 miles on Hwy 17 which becomes Big A Road. Turn right on Prather Bridge Road (GA-184 ) Proceed 5 miles and turn left onto Yonah Dam Road. Proceed 4.5 miles to Yonah Dam Park.

**Seneca, SC:** West on Hwy. 123 towards Westminster. From Westminster Ingles Store proceed 8.5 miles and turn right on Cleveland Pike Road (State road 37). Proceed 7.3 miles on Cleveland Pike which becomes Prather Bridge Road at the GA state line. Just past bridge over the Tugaleo River, turn right onto Yonah Dam Road Proceed 4.5 miles to Yonah Dam Park.

**Athens, GA :** Highway 106/ GA-29 through Danielsville and Carnesville to Hwy. 17 in Toccoa. Turn right on Highway 17 proceed to dead end, turn left (Walmart on left). Highway 17 becomes Big A Road continue 3.4 miles and Turn right on Prather Bridge Road (GA-184 ) for 5 miles and turn left onto Yonah Dam Road. Proceed 4.5 miles to Yonah Dam Park.
